

ON THE HYERS-ULAM-RASSIAS STABILITY OF A GENERAL CUBIC FUNCTIONAL EQUATION

Abstract. In this paper, we solve the generalized Hyers-Ulam-Rassias stability problem for a cubic functional equation $f(x+2y)+f(x-2y)+6f(x)=4f(x+y)+4f(x-y)$ in the spirit of Hyers, Ulam, Rassias and Găvruta.
